****NO PURCHASE NECESSARY**

****ENTRANTS MUST BE 6 YEARS OF AGE OR OLDER TO PARTICIPATE IN THIS CONTEST**

****CONTEST STARTS ON DECEMBER 21, 2008 AND ENDS FEBRUARY 21, 2009**

There are two (2) ways to enter:

1. On-line entry: From December 21, 2008 to February 21, 2009 log on to www.megabloks.com on the Internet and enter your name, address (with zip or postal code), age, answer to the Dragons question and click "Enter". Deadline for all online entries is 11:59 pm (EST) DECEMBER 21, 2008.
2. By facsimile: Fax your entry information to Mega Bloks® Dragons Anthology Contest at 1-800-377-9424. Information must be received no later than 11:59 pm ET February 21, 2009 and should have your name, address (with zip or postal code), answer to our question and age.
3. Maximum of one (1) entry per household per day, whether by Fax or Internet.
